Dr. Alan Schamroth, Calcutta Rescue



I am a family doctor in London who recognises that the individual health of my patients largely depends on public health (clean water and air, adequate sanitation, housing and nutrition). But public health itself depends on planetary health (thriving ecosystems, sustainable development, stable climates and peaceful co-existence). I began a post graduate degree in 'Global Health' 3 years ago and realised I needed field experience, so I volunteered to work with an NGO in Kolkata, India, called Calcutta Rescue. This NGO provides valuable primary healthcare to the slum dwellers of Kolkata. While in Kolkata I realised how vulnerable the city and especially the slum dwellers were to climate change from extremes in weather, forced migration, poverty & insecure employment. So began my relationship with the organisation to help build climate change resilience into all aspect of their work in terms of both mitigation and adaptation, using templates un-ashamedly borrowed from the WHO and modified to fit local circumstance.

Dr. Stuart Vallis, Swiss Agency for Development and Cooperation (SDC)



Since 2020 Stuart Vallis has worked for SDC in Bern. He is employed 50% for SDC Humanitarian Operations as a thematic advisor in sanitation and hygiene and 50% for SDC Section Health as a Health Program Officer. From 2010-2020 he worked as part of SDC's expert group in field missions in all 3 types of SDC humanitarian deployment, SET (emergency team), direct actions and secondment to UN organisations (UNHCR, UNICEF and IOM), mostly working in field projects in South Sudan, Iraq, Ethiopia, DRC and Chad. Stuart was deployed to DRC and Liberia during the Ebola outbreaks, working on IPC and reopening essential health services. From 2000-2010 Stuart worked in field projects for MSF and other humanitarian organisations as technical support for rural hospitals with

WASH services and renewable energy supply in Darfur, Northern Sri Lanka, Angola, DRC and the Brazilian Amazon.

Stuart has a PhD. In Physics from the University of Glasgow and Masters in Renewable Energy and Sustainable Building Technology from FHNW.
